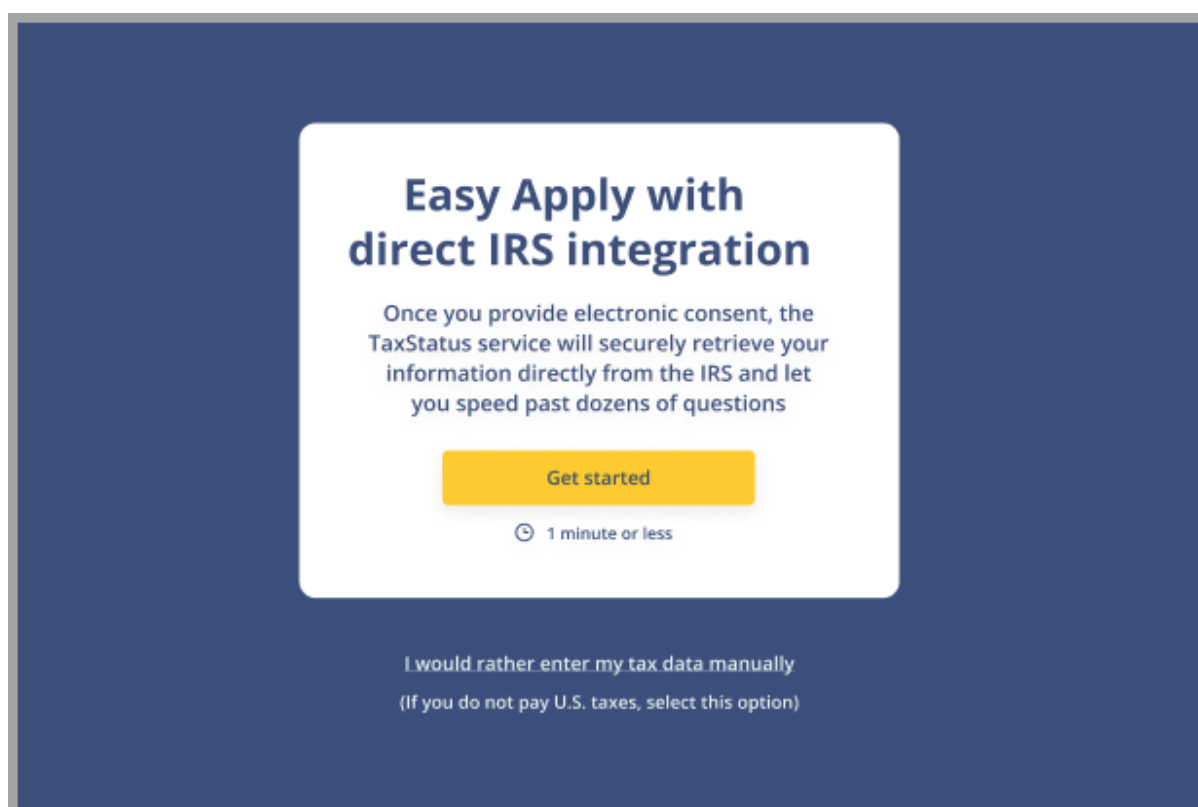
Sending IRS Data to your Application

New! Send your tax data directly from the IRS to your SSS financial aid application with TaxStatus

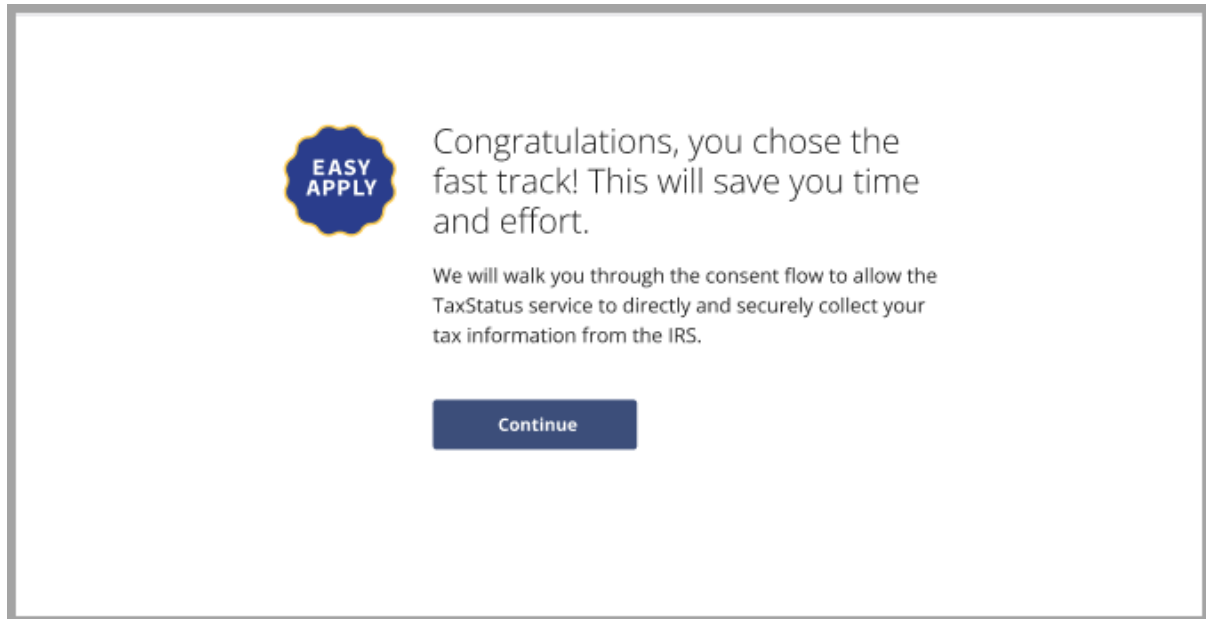
With SSS and TaxStatus, you can now provide consent for your IRS tax data to be directly sent to your financial aid application, eliminating the need to manually upload your tax documents like 1040s and W-2s.

How do I do it? The process is simple and fast! Follow the steps below to provide your consent for your tax data to be shared. You will also receive step-by-step instructions in SSS as you go.

1. As you complete your application, you will see a new step to share your tax information from the IRS, rather than manually uploading your documents. Simply click **Get started** to provide your consent for your data to be shared.




2. You will enter the consent workflow. Simply click **Continue** to get started with the first step: identity validation.



3. You have two options to validate your identity before submitting your consent:
 1. Using your ID.me account is recommended for the quickest process. This is the same account you use to view your data on the IRS website
 2. You also have the option to complete a manual identity verification process that will compare a photo of your legal identifying document (such as a driver's license) with a 180-degree selfie.

Your selected school(s) require you to submit tax information. The TaxStatus service will save you hours of time and effort by automatically, privately, and securely collecting your tax information from the IRS.

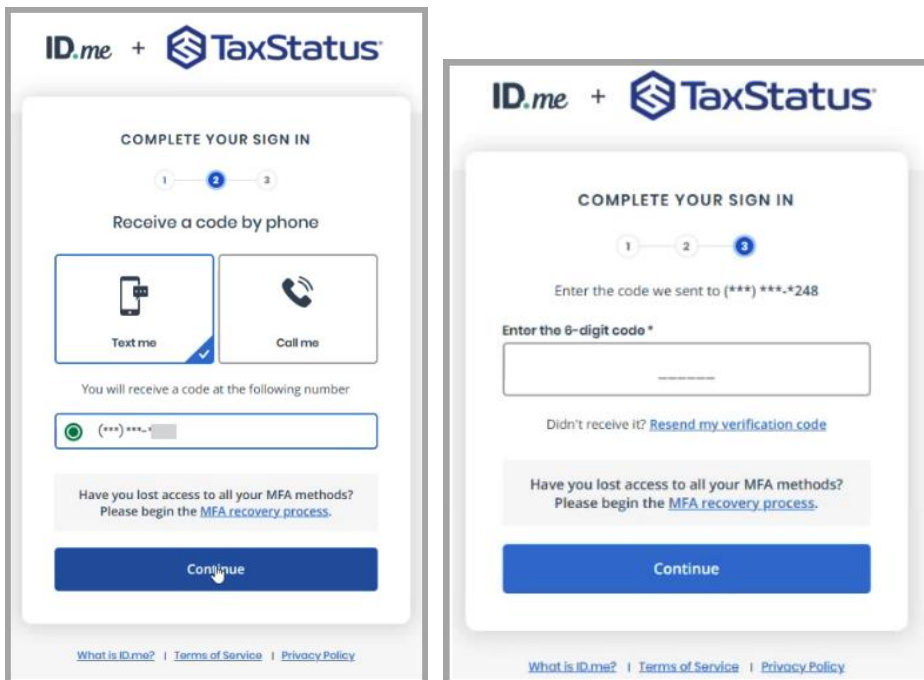

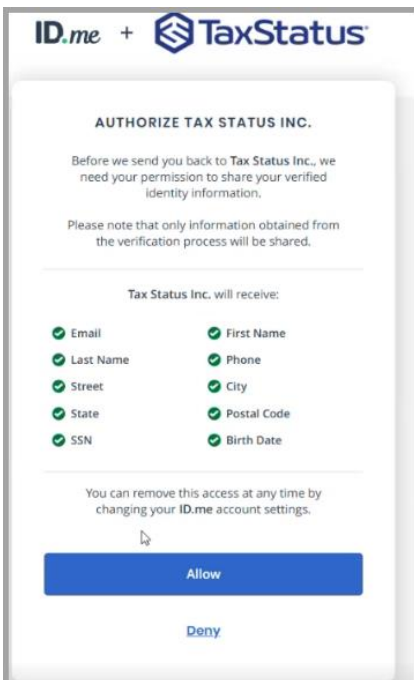

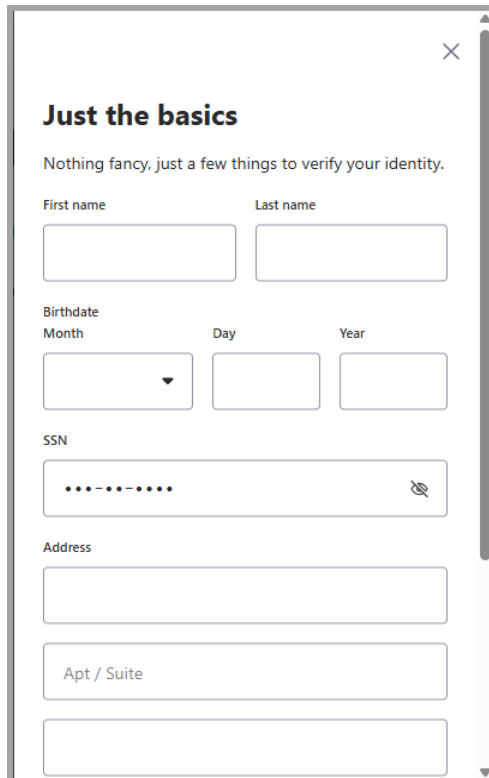

Manually Verifying Identity:

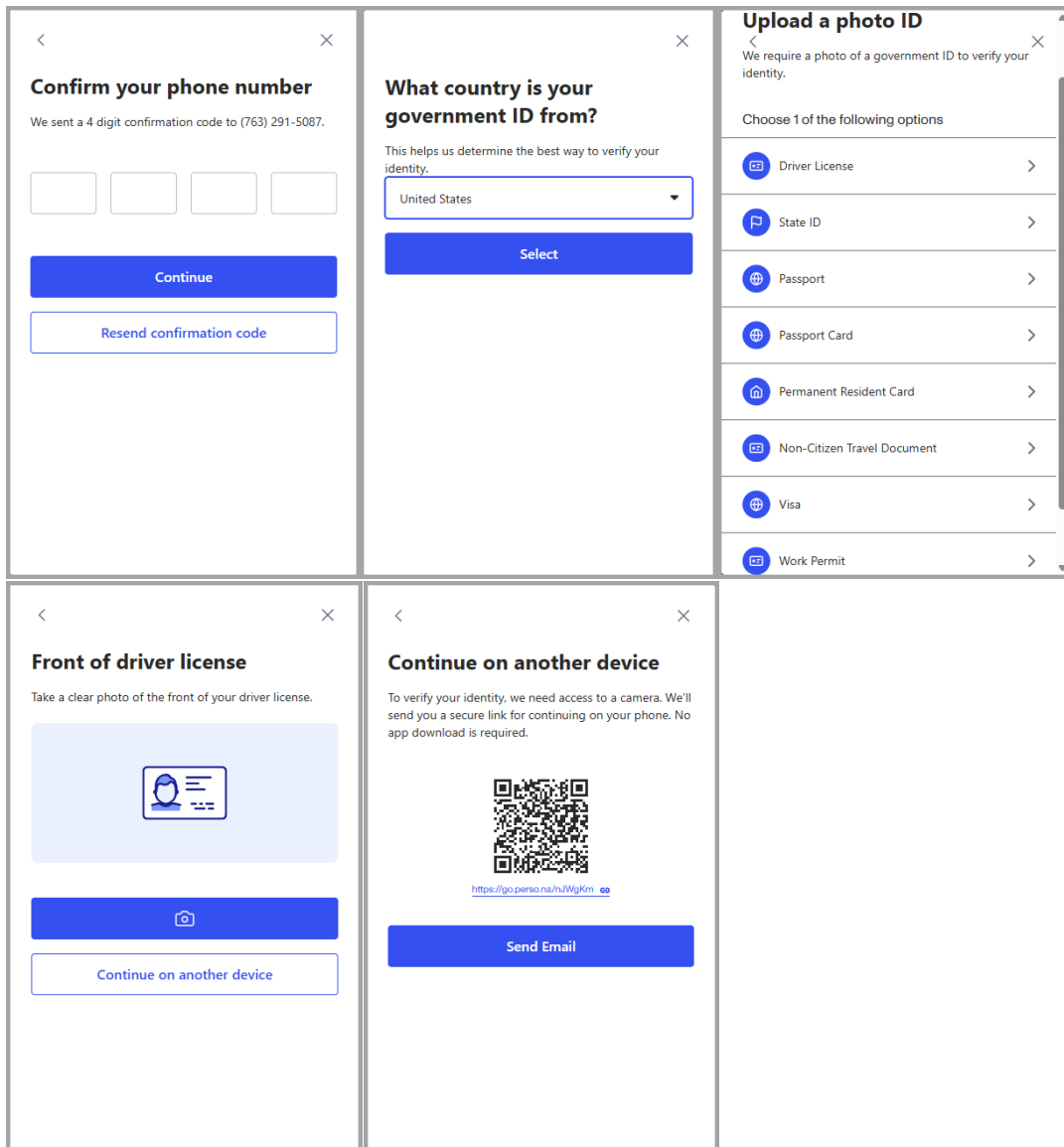
1. Most of your information will be pre-loaded from your Financial Aid application; however, you will need to enter your social security number for the IRS to process your consent form. **(SSS will never store your social security number).**
 - a. Ensure that your address listed matches the address where you last filed your federal taxes (1040).

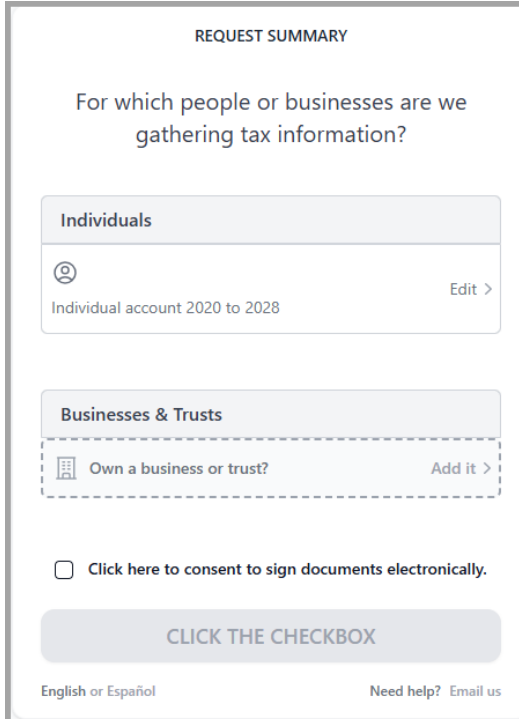

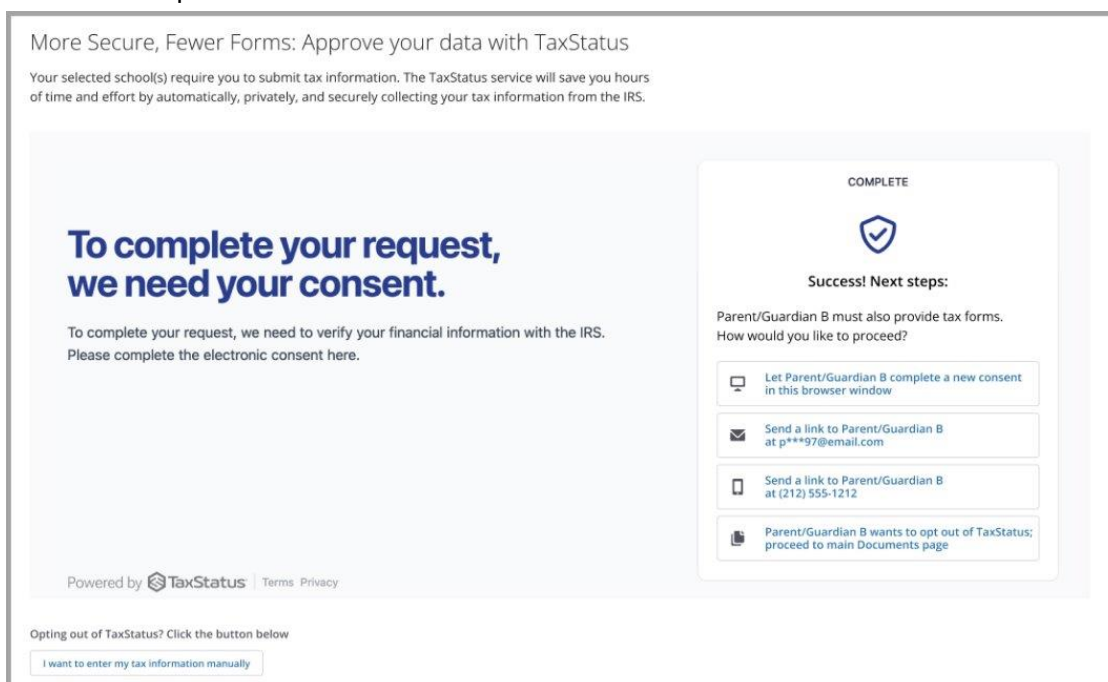
Click **Submit** to finalize the electronic signature and authorize the filing of IRS Form 8821 to collect your tax information.

After Submitting your Consent:

1. If you are the only Parent or Guardian in the household, you will see the options to either navigate to your Dashboard or to your My Documents page.

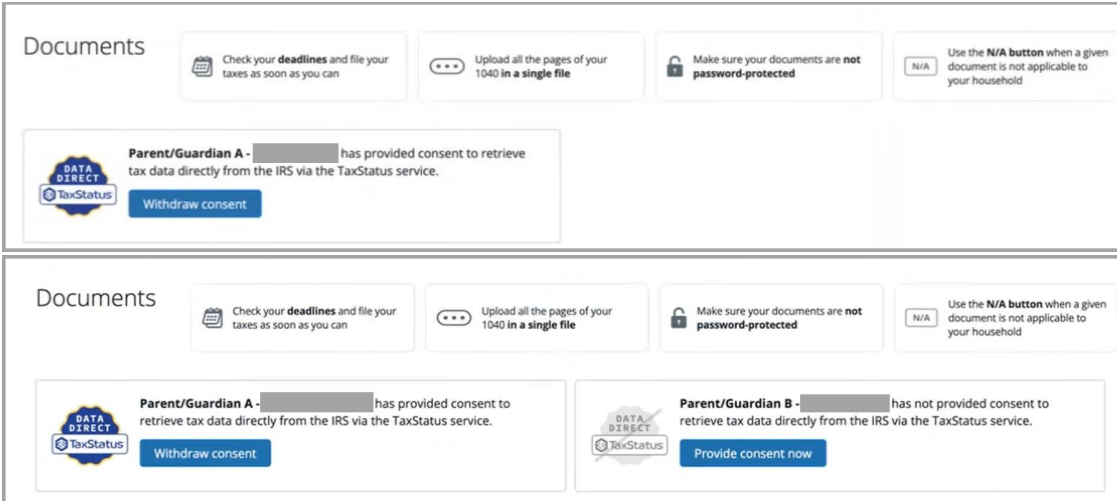


2. If there is a second Parent or Guardian in your household, they will also need to submit their consent form. This is because each individual taxpayer owns their tax data, and only they can provide consent to access that data. Parent or Guardian B can complete consent during your current session, or you may email or text them a link to complete their consent form later.



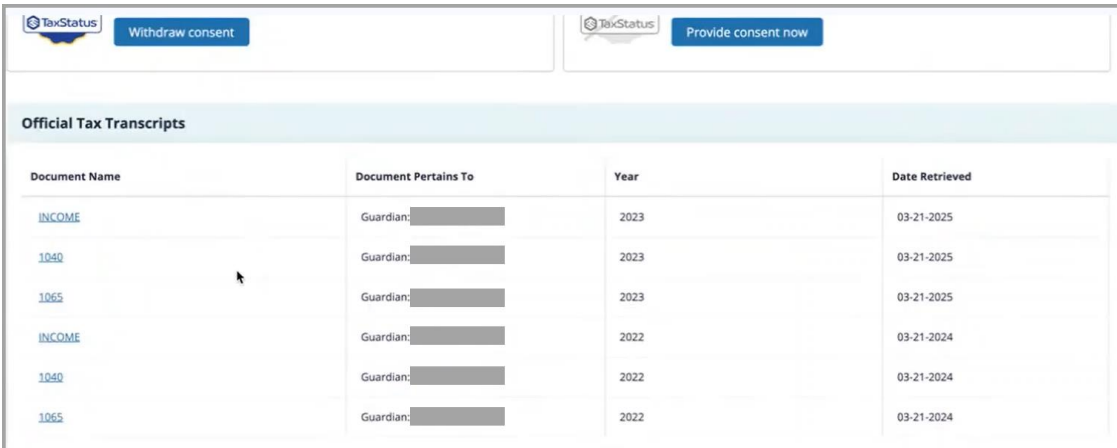
Viewing IRS Consent Status and Transcripts:

- From your **My Documents** page, you will be able to verify which Parent(s) or Guardian(s) have completed their consent form, granting easy access to IRS-direct data and documents. You can also add or withdraw consent from this page via the buttons on screen.

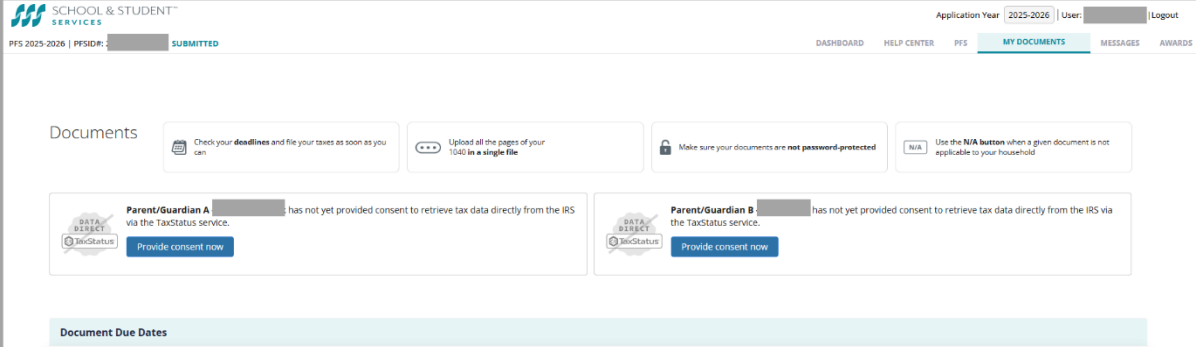

What if I have already manually uploaded all of my tax documents for my current Financial Aid application? No problem! Because your TaxStatus consent is good for three years, you can take the time now to get ahead for next year. And, because your updated tax data will be available when it's time to apply for Financial Aid again, you won't need to spend time searching for it – it's all right there for you.

To provide your TaxStatus consent in this case, simply log in, navigate to **My Documents**, and click the **Provide consent now** button to follow the normal process (detailed above).
